Talking to your Doctor about Omnipod DASH

Omnipod DASH is an insulin delivery system designed to help simplify your life and address many of your challenges. It is tubeless, waterproof,* easy and virtually painless to apply.

Deciding on the right diabetes therapy can be a big decision, and you don't have to make it alone. Use this guide to have a discussion with your health care provider to determine if Omnipod might be right for you.

Concerns	Why Omnipod
☐ I sometimes forget or skip doses.	Omnipod DASH provides up to 3 days (72 hours) of insulin minimizing missed doses.
I sometimes struggle to get my A1C to where my Doctor recommends.	T2 patients using Omnipod DASH saw a reduction in A1C by 2.3% in a retrospective study. ^{1,2}
Taking insulin injections multiple times per day gets in the way of my lifestyle.	Omnipod DASH replaces multiple daily injections (MDI – long acting, mealtime and corrections). One Pod replaces 14 injections. [†]
☐ I don't like giving myself injections in public.	You don't have to. The Pod is small and discrete, and the Personal Diabetes Manager (PDM) offers the flexibility to manage your insulin treatment in the palm of your hand.
Carb counting and logging meals is time consuming.	No more meal time logging. Omnipod DASH has a preset bolus feature and an integrated bolus calculator and the CalorieKing® library of 80,000+ foods.
☐ I don't think I can afford a pump.	On average people pay less than \$50 per month, [‡] and those on medicare even less. Plus, no longer need long-acting Insulin while on Omnipod DASH.
I am not confident that I will be able to learn how to operate it—will someone help me?	Omnipod is designed to be simple to operate. Once you fill your prescription and have your new Omnipod DASH you will be connected to a Certified Pump Trainer and Omnipod Specialist to help get you started.
☐ Is Omnipod DASH approved for people with T2 diabetes?	Omnipod DASH is approved for people with Insulin-requiring type 2 diabetes—and because it is through the pharmacy no c-peptide test required.
